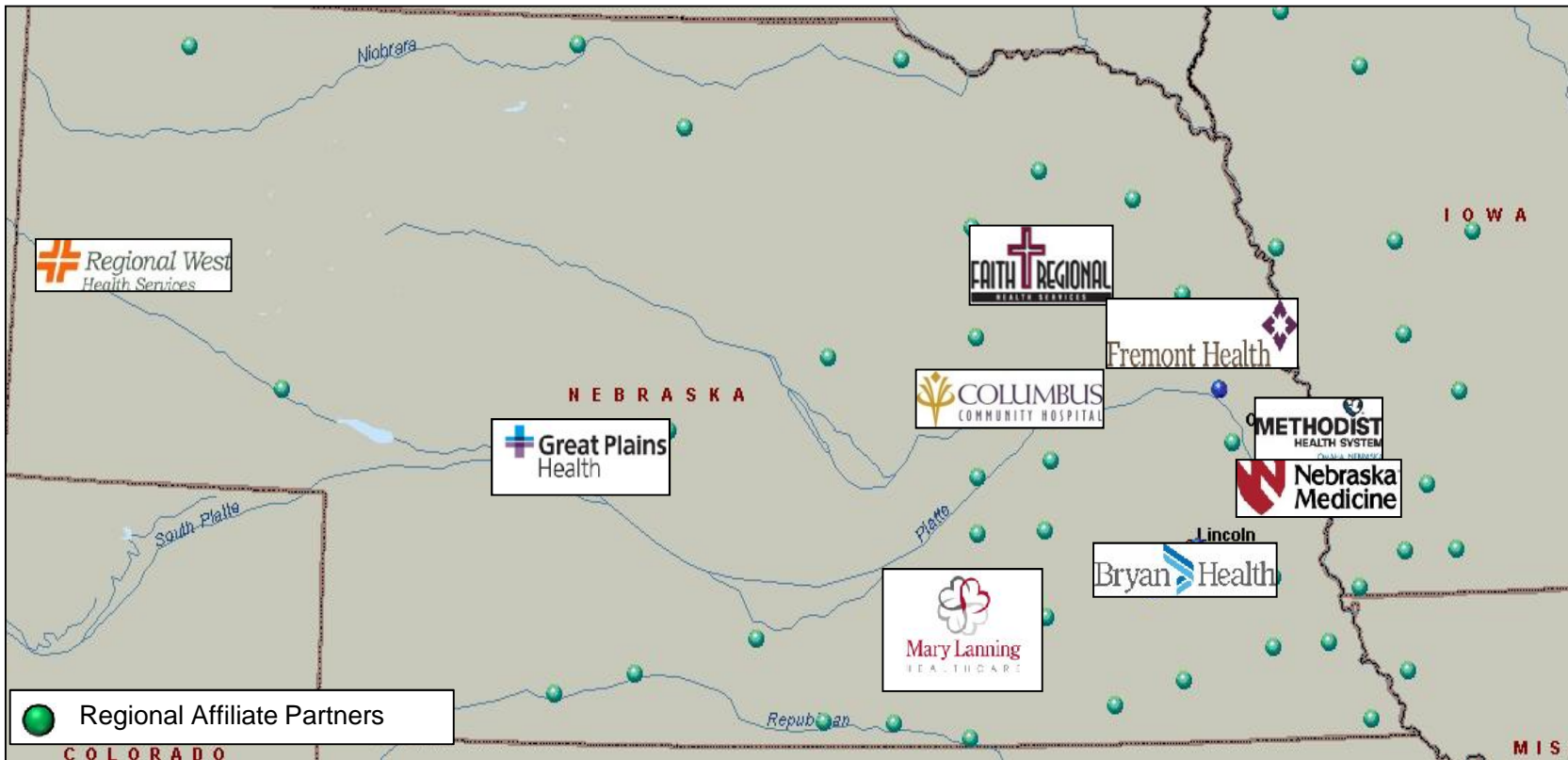


# RPN Scope:
